#### **TOURNAMENT INFORMATION**

#### I. HHSAA AIR RIFLERY REGULATIONS

HHSAA Air Riflery Regulations may be found in the HHSAA section included in this packet.

#### II. LEAGUE ENTRY FORM

Each League's Sport Coordinator shall be responsible for submitting their Boys and Girls League Individual Entry Forms, including alternates, which must include all of their league qualifiers for the state tournament. The entry form will be sent to each league sport coordinator by email. HHSAA Air Riflery Coordinator must receive these forms by 4:30 p.m. on Wednesday, October 19, 2016. League Sport Coordinators must email entries to <a href="mailto:frederichu@aol.com">frederichu@aol.com</a> with copies sent to the chief statistical officer, Robynn Hata at <a href="mailto:hatas@hawaii.rr.com">hatas@hawaii.rr.com</a> and to the HHSAA at roster@hhsaa.org.

Each League Sport Coordinator shall be responsible for submitting their Boys and/or Girls League Team Entry Forms, including alternates, which must also include the names of all of their school qualifiers for the state tournament. The HHSAA Air Riflery Coordinator and Chief statistical Officer must receive both the Team and Individual entry forms by the deadline noted above.

#### VI. TOURNAMENT RULES AND REGULATIONS

The tournament shall be governed by the applicable rules and regulations of the HHSAA and the current National Standard Three-Position Air Rifle Rules published by the National Three-Position Air Rifle Council, except as modified for this tournament.

#### VII. CODE OF CONDUCT

The Head Coach shall have direct responsibility for the conduct of coaches and team members prior to, during, and after tournament competition (including at the hotel, in public areas, at the tournament site, and during transportation to and from the tournament site).

The HHSAA Executive Director may establish a common curfew hour as necessary.

The drinking of alcoholic beverages, smoking, illegal or illicit drug use, loud, unruly, or destructive behavior will not be tolerated.

Coaches are requested to inform their athletes of hotel rules and regulations. Please emphasize the importance of appropriate conduct and behavior, and consideration for other hotel guests. Schools and/or students will be charged for any damages incurred by them at the hotel.

It is recommended that schools inform the parents of violators of this Code of Conduct.

#### **HHSAA AIR RIFLERY REGULATIONS**

#### I. SPECIFIC OBJECTIVES

- A. To select a state individual and team Air Riflery champion for boys and girls through tournament competition.
- B. To recognize the combined efforts of all participating teams and schools in the tournament.
- C. To promote and encourage the highest principles and standards of attitude and positive behavior.
- D. To promote the highest principles of good citizenship in tournament competitions.
- E. To promote safety awareness at all times.

#### II. OFFICIALS

Officials shall be selected by the Sport Coordinator and approved by the HHSAA Executive Director.


#### III. ELIGIBILITY

Each participant must be eligible under the rules of his/her league and under the eligibility requirements specified by the HHSAA.

#### IV. TOURNAMENT REPRESENTATION

Each league shall determine the method of selecting their entries, subject to the following allocation of participants for each league:

- A. Representation for the tournament is limited to 60 boys and 60 girls. No league's entries should fall to less than five (5) according to the formula for selecting each league's number of entries.
- B. With respect to each gender, the number of representatives for each league shall be determined by the following formula:



All fractions of more than one-half shall be counted to the next whole number, with highest percentages considered to keep the total number of entries at the specified limits for boys and girls.

C. Schools may bring an unlimited number of individuals to the tournament, as long as they are qualified by their respective league and the league's entries to not exceed the total number allocated by the formula for determining league representation.

D. The slot for a qualified participant who cannot participate in the match belongs only to the league in which that athlete participates. Substitutions will come from the list of league alternates, following that league's rule for participation in HHSAA state tournaments. If the league cannot fill the vacancy with an alternate, the vacancy shall remain unfilled.

#### V. ENTRY DEADLINE

A. A school's list of entrants shall be submitted to the Sports Coordinator six days prior to the start of the tournament. Please see the entry form for specific date/time deadline. This list shall include two alternates for each category.

B. Additionally, the names of the shooters who will make up a school's team for purposes of team scoring competition, including the use of a qualified alternate (those previously listed and submitted on the league's entry form), shall be provided to the statistical office no later than 15 minutes prior to the start of the tournament. Substitutions and alternates shall be determined by that league's coordinator or the league's designated representative (school's team coach) provided that no school may enter more than one team per gender. (Rev. 06/2016)

#### VI. GENERAL RULES AND REGULATIONS

A Competitors' briefing sheet will be provided to each Air Riflery State Tournament participant.

<u>Rules</u>: Current National Standard Three-Position Air Rifle Rules ("National Standard Rules"), with HHSAA provisions, exceptions and modifications as necessary.

Equipment Inspection: All equipment must be inspected prior to use in competition.

Rifle: National Standard Rule 4.2 Sporter Air Rifle.

Positions: Rule 5.1

Course Of Fire: Rule 5.3.3 Plus Finals (Rule 10.0)

Sights: Rule 4.2.8

<u>Distance</u>: 32 feet 9.7 inches (10 meters) Rule 5.5.1

Sighting Shots: Rule 7.12.1

Time Limit: Rule 5.3.3 (Individual Event 3x20 Plus Finals)

<u>Target</u>: Rule 5.4 (note: only targets provided by HHSAA will be allowed)

<u>Protest Fee</u>: A challenge fee of \$1 will be charged per protest. <u>See</u> Rule 9.0 for procedures. The HHSAA Air Riflery Coordinator shall serve in the capcity of, in all situations, with respect to all references, rulings, protests, and appeals to the competition Jury, National Council, or National Jury of Appeal, and shall serve as this Tournament's final authority in all respects.

<u>Protest Time</u>: The protest time will be posted on the scoreboard. The protest time shall be 20 minutes. The official time will be the time kept in the statistical office.

Tie Scores: Ties will be broken in accordance with Rule 8.6.

Coaching: Coaching is permitted pursuant to the guidelines set forth in Rule 5.2.1.

<u>Competition Director</u>: The HHSAA Air Riflery Coordinator shall serve as the Competition Director.

#### VII. COMPETITION

- A. Course of Fire: Two-year pilot program (2016-17, 2017-18 SY) adopting Rule 5.3.3 Individual Event, 3x20 Plus Final: . See Rule 5.3.3. Twenty (20) shots in each of the following positions: prone, standing, and kneeling, one shot per bullseye. The positions must be fired in the order listed above. (Adopted 06/2016)
- B. All participants shall be pre-squadded by the HHSAA Air Riflery Coordinator.
- C. The individual champion shall be determined by his/her total aggregate score of the three (3) firing positions plus Finals.
- D. Team Match see Rule 5.3.5 Team Events 3x20. The total aggregate scores of the four (4) designated shooters for their particular school shall determine the team championship.
- E. Starting with the 2011 Tournament, the boys tournament will be shot first in odd numbered years. The girls tournament will be shot first in even numbered years.

#### VIII. UNIFORM

All participants are encouraged to wear school-designated uniforms, preferably with school-identifying insignia.

#### IX. SAFETY

A. Eye Protection: Adequate eye protection must be worn while on the firing line by all persons when firing is in progress. (Rev. 06/2016)

- B. Dry Firing: Dry firing is not permitted anywhere, except during the preparation period or during live fire on the firing line.
- C. The safe handling of Air rifles must be practiced at all times.

#### X. TOURNAMENT SITE

- A. The HHSAA Executive Director shall select the tournament site.
- B. A centralized location for the tournament is recommended in order to minimize problems in transporting equipment and parking, and to ensure adequate scoring facilities, restrooms, and holding areas. Also, the tournament site must contain a minimum of twenty (20) firing points, with such firing points complying with Rule 5.5.2.
- C. Beginning in 2015, the following league hosting rotation is MIL, OIA, ILH, BIIF, OIA, ILH, etc... (Rev. 6/2013)

#### XI. AWARDS

- A. Permanent trophies to boys and girls championship teams.
- B. Permanent trophies to boys and girls runner-up teams.
- C. Gold medals to the championship teams for boys (4) and girls (4), plus one for their head coaches.
- D. Gold medals to individual champions for boys and girls.
- E. Silver medals to the individual runner-up for boys and girls.
- F. Bronze medals to individual places 3-10 for boys and girls.

#### XII. EVALUATION

An evaluation report and tournament results shall be submitted to the HHSAA Executive Director within two weeks after the tournament.

#### **COMPETITION BULLETIN 1-16**

Governing rules for this Tournament is contained in the 2014-2016 National Standard Three-Position Air Rifle Rules, 10<sup>th</sup> Edition, except as modified for this Tournament.

SAFETY FIRST: An approved clear barrel indicator (CBI) must be used to clearly indicate that a rifle is clear and safe. All bolts and pump handles must remain open until instructed otherwise by the Chief Range Officer on the firing line. When transporting an uncased rifle, the CBI must be clearly visible and the muzzle must point up and held in a manner that assures that the muzzle is well above head level. Adequate eye protection is mandatory and must be worn by all persons on the firing line (competitors, coaches, and staff) while firing is in progress. Hearing protection is optional.

**Team Rosters:** Team rosters, including the use of an "alternate" team member from the submitted entry, if applicable, must be submitted to the Stat Office no later than 15 minutes prior to the first "Start" command of this Tournament. Team entries, or substitutions of team members, will not be allowed or accepted thereafter.

Loading and Closing the Action: You may load your rifle only when you are on the firing line and instructed to do so by the Chief Range Officer. Loading from the ground is permitted in the prone and keeling positions, but loading in the standing position must be from a height not below the shooter's knee. Loading from the ground in standing is not permitted. When closing the action in all positions, the muzzle of the rifle must be pointing below the top of the target frame. Trigger fingers must remain outside the trigger guard until you begin to aim at the target.

**Target Identification:** Targets must be identified correctly or they will not be scored. It is the competitor's responsibility to make certain that the information

on the target stickers issued at check-in is accurate. No additional writing or marking of targets is allowed. Only targets issue by the Tournament may be used. The first target card, Stage 1, shall be placed on the left. The second target card, Stage 2, shall be placed on the right. The target number is your firing point number.

Check-in and Equipment Inspection: Equipment inspection begins at 6:30 a.m. Each competitor shall check-in at the Stat office to receive his or her targets, competitor number, point assignment, and inspection Form. Please provide the information on the top portion of the Inspection Form before taking your place in the inspection line with your rifle and equipment. "Back-up" rifles or other equipment must also be inspected during this inspection period or may not be used in this match. A muzzle velocity check may be included in the equipment inspection. An inspection sticker will be issued when the inspection is complete and it is the competitor's responsibility to keep the completed Inspection Form with the rifle at all times. A Range Officer can request to view the Inspection Form at any time during the competition.

**Scoring:** The Orion scoring system will be used. (See also Rule 8.5.3)

**Coaching:** Coaching is permitted only during the preparation and sighting or changeover stages as specified in Rule 5.2.1. During any Record Fire Stage, an athlete, while on the firing line, may only communicate with a Range Officer or Jury Member (Tournament Director).

JROTC Competition: To qualify for the JROTC awards, cadets must meet the eligibility criteria of Rule.3.2. Only cadets from JROTC program schools that have been approved for marksmanship programs are eligible for this award. All entries must be received by 4:30 p.m. on Wednesday, October 19, 2016. Entries shall include the cadet's full name, gender, and School/JROTC program name. While not a part of the HHSAA Air Rifle State Championships, scores from the HHSAA Air Rifle State Championship Tournament shall be used to determine the winner of the JROTC awards.

#### **Relays Plus Finals**

For the 2016 Tournament, there will be two relays of 60 shooters per relay.

Relay 1 60 girls followed by Finals Relay 2 60 boys followed by Finals

#### FINALS COMPETITION PROTOCOL

Rule 10.0 shall govern the Finals Competition, except as modified for this Tournament. Final Round scores shall be added to the three-position score to determine the individual Tournament winners.

- 1. The top eight (8) shooters qualify to advance to the Finals Round. The course of fire is ten (10) shots in the standing position, fired singularly, one at a time.
- 2. Competitors shall be assigned firing points in accordance with Rule 10.2.1.
- 3. Targets are to be shot in numerical order starting on bull's-eye number one (1) and ending with bull's-eye number ten (10). Shooters are allowed fifty (50) seconds to fire each shot.
- 4. Range Officers shall hold their hands above their heads until the shooter released their shot at which time the Range Officer shall lower their hand. At the end of the allotted time for a shot, when the Chief Range Officer orders, "Stop", each Range Officer shall hold up a scorecard indicating the estimated value of each shot.
- 5. Because we using paper targets, only an estimated value will be revealed for each competitor after each shot but all targets will be officially scored using the Orion system at the completion of all ten shots. The estimated score for the tenth target is not announced.

- 6. Competitors may only charge and load a pellet upon the order of the Chief Range Officer. This shall include the pumping or charging of a rifle if required or so equipped.
- 7. In the event of a malfunction that is determined to not be the fault of the shooter, the malfunction must be repaired or the rifle replaced within two (2) minutes. An additional fifty (50) seconds is allotted to the shooter to execute the malfunctioned shot. No additional time shall be awarded for sighting shots except in the case where the shooter is moved to another target. In this case, a maximum of two (2) minutes for sighting shots is allowed. If the malfunction or repair is not remedied or if the the malfunctioned rifle is not replaced within two (2) minutes, the competitor shall withdraw from the finals. Rule 10.3.5.
- 8. The combined three-position score and the Finals score are added together to determine the Tournament individual winners.
- 9. During the Finals, team members, coaches, parents, and spectators are encouraged to applaud and cheer during the Finals except during the fifty (50) seconds while competitors are actually shooting (between the Chief Range Officer's commands to "Start" and "Stop"). Rule 10.2.5.

#### CMP WESTERN REGIONAL TOURNAMENT INVITATION

The CMP Western Regional will be held on April 6-8, 2017 at the Davis Convention Center in Layton, Utah. The winning team from this State Tournament is invited to compete in this Western Regional and the CMP has generously pledged significant monetary support to help defray the team's travel expenses.
